# Welcome to Temple University Continuing Studies!

Continuing Studies, the home of Temple's non-degree students taking credit courses, is excited to welcome you to the Temple community. This packet provides you with pertinent information about being registered for courses at Temple. Please read through carefully and if you have any questions please don't hesitate to contact us.

## **Setting Up Your Online Account**

24 hours after you register for courses, you are required to activate your AccessNet account. This will allow you to log in to the TUportal. (If you experience difficulty you may contact the help desk: 215.204.8000).

- Go to <u>accounts.temple.edu</u>
- In right hand side bar, click "Activate AccessNet account."
- Enter your last name, birth date and your 9 digit TUID number.
- Follow the instructions to activate your account. You will now be able to access everything through the TUportal.

## **TUportal**

<u>tuportal.temple.edu</u> is where you will be able to view your Temple email, bill, roster, student information, Canvas course companion, advising session reports and other pertinent information.

# Your Bill

Once a bill is generated, a notification will be sent to your TUmail email account. Temple only sends bills electronically. You will NOT be sent a paper bill in the US mail. You may also view your bill directly:

- Log in to tuportal.temple.edu
- Click on the Student Tools tab
- Click on TUpay on the right

If you register for courses you WILL have a bill. It is very important to drop courses through a Continuing Studies advisor by the deadline if you do not intend to take courses.

If you plan to use financial aid but do not get approved (or do not get approved before the drop deadline), it is your responsibility to drop your schedule through a Continuing Studies advisor by the deadline (or plan to pay out of pocket).

If the drop deadline passes and you fail to drop your courses you will have a bill and be responsible in full for tuition and fees. (Your classes will not necessarily be cancelled if you do not pay).

## **Drop/Add and Withdrawal Policy**

Know the drop/add and withdraw policies <a href="https://bulletin.temple.edu/undergraduate/about-temple-university/registration/#schedule-revision">https://bulletin.temple.edu/undergraduate/about-temple-university/registration/#schedule-revision</a>. After the drop deadline registered students are responsible for full tuition and fees. As a Continuing Studies student you must drop/add and withdraw through an advisor, you do not have access to doing this online. We will provide you with written confirmation or email when you make a schedule revision. Please keep the confirmation for your records. You should always verify your schedule for accuracy by logging into the TUportal.

Last day to drop a Summer I course Tue, May 20
Last day to withdraw a Summer I course Fri, June 20

Summer II semester begins Mon, June 30
Last day to drop a Summer II course Sun, July 6
Last day to withdraw a Summer II course Fri, Aug 1

#### **Important Dates Fall 2025**

For full-term 16-week courses:

Fall semester begins Mon, Aug 25
Last day to drop a Fall course Mon, Sep 8
Last day to withdraw a Fall course Mon, Dec 8

### **TUID Card**

After you register you are able to obtain an ID card at the Diamond Dollars office located in the Howard Gittis Student Center, suite 101 (<a href="https://finance.temple.edu/owlcard">https://finance.temple.edu/owlcard</a>). You will need this ID card to enter Temple University buildings and to have access to services such as the library and computer labs.

## **Books**

# Detailed Billing and Payment Information

Registered students with a balance due will be issued an e-bill in accordance with the billing schedule: <a href="http://bursar.temple.edu/billing/billing-schedule">http://bursar.temple.edu/billing/billing-schedule</a>

If you are registered at the time the first e-bill is generated, up to three e-bills could be issued for the fall and spring semester. Newly registered students are billed for the first time on the Monday following their initial registration date.

# Bill Delivery

Because e-mail is the official means of communication for Temple University, only electronic bills (e-bills) are issued for currently registered students. Paper bills will not be mailed. Bill notifications are sent to your official Temple e-mail account and bills are available to be viewed in TUpay.

# **Bill Amounts**

Students are encouraged to pay the total account balance by the due date. In doing so, students avoid any payment plan fees and late payment fees. However, if you are un-able to do so, Temple University offers two payment plans outlined below to help students and their families. The two payment plans are the Deferred Payment Plan or the Temple Installment Payment Plan (TIPP).

Please note that these two payment plans are offered for the fall and spring semesters only. Payment plans are not offered in the summer semesters. For summer semesters, students are required to pay the total account balance by the due date.

# Deferred Payment Plan

For the fall and spring semesters, students that do not pay the total account balance will be automatically enrolled in the University's Deferred Payment Plan. The Deferred Payment Plan provides additional time to pay your balance.

Students will be assessed a \$50 non-refundable payment plan fee each semester if the total account balance is not paid by the semester due date. Students do not have to sign up for this payment plan. If students are automatically enrolled in the Deferred Payment Plan for fall and spring, the annual fee is \$100.

# ONLINE (TUPAY)

Students and authorized payers can pay online via <u>TUpay</u> by electronic check or credit card. All online payments submitted through <u>TUpay</u> are posted to the student account in real-time. Click "Current Account Activity" in TUpay to see the payment posted. Learn more about how to access TUpay.

# Electronic Check (E-Check)

E-check is a fast and secure method to electronically pay your bill. An e-check payment can be made from a checking or savings account with no additional fee for this real-time transaction. If you are not familiar how to use this payment option, a tutorial is provided in TUpay on the Make Payment Page.

Please note that an electronic check payment submitted through your online banking system is not considered an e-check by Temple University. These payments are remitted by your bank to Temple via US mail and can take several days to be received and posted to your student account in TUpay.

# Credit Card

Visa, MasterCard, Discover and American Express are the accepted credit card types. Credit card payments are subject to a 2.75% convenience fee by the vendor in addition to tuition and fees.

Please note that if a credit card payment results in a credit balance on the student account and a refund is authorized, credit card companies require that the refund be processed back to the original credit card. Refunds are made as long as the refund payment occurred within three months from the date of payment. Any credit card refund older than three months from the payment date, will be issued via direct deposit or check.

# Financial Responsibility Agreement

Students will receive an e-mail reminder of this Financial Responsibility Agreement whenever a registration transaction is processed by you or an academic advisor on your behalf.

Your registration will <u>not</u> automatically be cancelled for non-payment of tuition and fees. If you <u>do not plan to attend</u> the semester, you must drop your registration by the end of the drop-add period as shown on the <u>academic calendar</u>. You will remain financially responsible for your tuition and fee charges if your registration is not dropped.

# Student Financial Responsibility Agreement

I acknowledge that by registering for classes at Temple University, I agree to pay all assessed tuition and fees that result from my initial registration and/or future drop/add activity. I understand that I am responsible to pay for all classes in which I am registered after the final day of the term's drop/add period, which is published on the University's Academic Calendar.

I understand that if I am not planning to attend, it is my responsibility to drop my classes as the University will not automatically cancel my registration.

I understand that Temple University will notify me about my outstanding charges and debt via my Temple.edu e-mail account or through TUportal. I further acknowledge that payments must be received on or before the due dates listed on my e-bills and that I may be charged late payment fees for delinquent payments.

I agree that Temple University may restrict my right to register or receive other University services in accordance with University policies until I pay all past due balances. I understand that any delinquent debts may/will be reported to a credit bureau and referred to an outside collection agency and that I am responsible for all additional costs for collecting my unpaid balance. I also understand that the University reserves the right to cancel any registration because of a delinquent unpaid debt.

In addition, I agree to allow Temple University and its agents to contact me at any cell phone number that I provide now or use in the future, using automated telephone dialing systems, artificial or pre-recorded voice or text messages, or personal calls regarding my obligation to repay my debts to Temple University. I also authorize Temple University or its agents to contact me via my temple.edu address or an email address that I provide to the University. I understand that others may be able to access my messages and/or emails and their contents, which may include information about my debt and its status.
